World-Class Health Care for Youth Right Here in Auburn Gresham

Ghe University of Chicago Pediatric Mobile Care Van has partnered with the Greater Auburn-Gresham Development Corporation (GADC) and Perspectives Charter Schools-Calumet Campus (PCS) to bring pediatric healthcare services (at no cost) to the Perspectives-Calumet students. The "hospital on wheels" brings medical resources to Chicago schools so

parents or guardians don't have to overcome obstacles, such as transportation, to get their child to a healthcare professional.

To accomplish this task, GADC and PCS-Calumet have partnered with Chase Woodward of the Chicago Health Corps (a division of Ameri-corps), to work within the PCS-Calumet campus. Woodward is a Northwestern University graduate and future physician.

The Mobile Care Van's medical staff (a pediatrician, a nurse practitioner, a program manager, and a driver) is passionate about improving access to healthcare for the youth of Auburn Gresham.

These partnerships are part of a GADC "Early Action Project" sponsored by Local Initiative Support Corporation (LISC) to improve healthcare for youth in Auburn Gresham.

Foreclosure Busters in the Hood

As everyone has heard on local and national news, read in the newspapers, and even participated in some forums on "keeping your home"; **FORECLOSURE** has become a household word. Neighborhood Housing

Services of Chicago (NHS) – the Auburn Gresham / Englewood branch has counseled many people in home mortgage default during 2007 and helped them to avoid foreclosure.

Though a very arduous process, Deborah Moore, Director for this neighborhood branch, and her team continue to treat each client with dignity and respect while helping to solve their hardship.

"Saving families from losing their home and investment, in addition to saving our neighborhood from another vacant, boarded up house is currently the most important work to accom-

plish," said Ms. Moore.

Before coming to NHS, Deborah earned her MS from Spertus College in Affordable Housing Development and Human Services Administration and served as a Development Specialist for Shorebank Corporation's non-profit housing organization. In that role, she developed multi-family and commercial facilities in the South Shore and Austin neighborhoods.

2007 was a good year for first-time homebuyers who purchased homes in the Auburn Gresham and Englewood communities. NHS partnered with GADC and Harris Bank to sponsor

a Developers Forum where hundreds of potential homebuyers were able to have a virtual tour of all the new housing developments slated for these communities.

This NHS neighborhood branch also celebrated their 10th year anniversary in the Auburn Gresham and Englewood communities. Northern Trust Company located at 78th & State sponsored the gala.

GADC wants to raise awareness of the benefits of recycling and litter prevention and has partnered with several local schools and SOS Children's Village to launch recycling campaigns at each. This pilot program includes the following schools: Simeon Career Academy, Oglesby Elementary School, and Perspectives Charter Schools-Calumet Campus. Hubert has spent 37 years working in the community as a store manager for both Jewel Food Stores and Dominick's Finer Foods. The last ten years he worked for the City of Chicago before he retired in June of 2006 as Streets & Sanitation Superintendent of the 17th Ward.

Auburn Gresham/Englewood Year in Review



Local residents were among the first to receive free tax services at the Auburn Gresham's free tax clinic. Services were offered in partnership with GADC, the St. Sabina Employment Resource Center (ERC), and the Center for Economic Progress (CEP).

Mayor Richard Daley joined Alderman Latasha Thomas (D-17), City Treasurer Stephanie Neely, City Clerk-Miguel Del Valle, Cleanslate Interns, and a host of other dignitaries and local residents at BJ's Market & Bakery to celebrate the community's accomplishments.

Nearly 50 local residents, Perspectives Charter Schools (PCS) teachers, parents, students, and civic & community leaders attended GADC's first planning session for the Integrated Services in School (ISS) project, including plans for a school-based health clinic at PCS.

Mayor Daley joined Chicago Police Department's Dana Starks, a concerned resident, Senator Jacqueline Collins (Legislative-16), Father Pfleger of St. Sabina Church, and Alderman Howard Brookins (D-21) in a march to protest violence in the City of Chicago.

GADC Partners with St. Sabina's ERC and CEP for Free Tax Preparation



The Greater Auburn Gresham Development Corporation (GADC), the St. Sabina Employment Resource Center (ERC), and the Center for Economic Progress (CEP) will offer free tax preparation at the St. Sabina ERC (1153 W. 79th St.) on **Monday, Thursday, and Saturdays, between January 26 and Monday, April 14, 2008.** Families earning under \$40,000 and individuals earning under

\$15,000 are eligible for this service.

Help is provided on a first come, first serve basis and bank representatives will be available on site to help people open checking and savings accounts.

Also, if you are interested in becoming a volunteer tax preparer, CEP is looking for Volunteer Tax Preparers to help Auburn Gresham families file their taxes and get the refund they've earned.

Free, flexible training is avail-

able through the month of January and volunteers will get a chance to learn new skills, meet new people, and help Chicago families get ahead.
