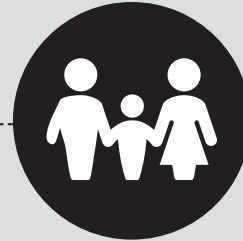
- All W-2s and 1099s (if any)

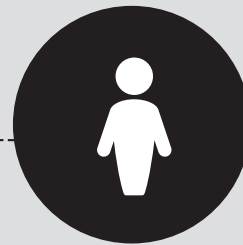
