The 200 to 300 residents, business owners, clergy and activists gathered with elected officials at St. Sabina's Bethune Hall to take part in the unveiling ceremony. The celebration also included recognizing the accomplishments of: the GADC organization, the 40 member task force, active block club members and associations and other community eaders for the completion of the Quality of Life Plan. In addition, we provided spotlights on relationships and success stories that have emerged since the inception of the plan.

The drum line then launched into an awe-inspiring performance the program concluded. During the program, all attendees were served lunch by volunteers from Leo High School and given quality of life plans with maps, understanding that the community must work together to rebuild a sustainable, viable neighborhood. The event ended with high-spirited comments from Pastor Pfleger. For the 100 or so people that refused to leave the celebration, we had DJ Jermaine spin the unplanned after-set which asted for an additional two hours.

## UNVEILING OF THE QUALITY OF LIFE PLAN

Several residents who were in attendance stated that "the spirit of the celebration will last a life time." The atmosphere of the celebration was very much that of a unified and uplifted community. The Leo High School Jazz Band, in full uniform, entertained the crowd at the beginning and end of the program. Englewood's Kaotic Drum Line wowed the crowd with a rhythmic entrance of the veiled Quality of Life plan (under lock and key) escorted by gloved, ROTC-like officers. As the plan made its way to Executive Director Nelson, the drummers built the excitement with a thunderous crescendo. The plan was then unveiled along with the map of key projects planned for the community. After a brief discussion about the two-year planning process, presentations and congratulations to the residents of the community for their work on constructing 'their' plan, awards were given out to leaders and a special recognition for the Local Initiatives Support Corporation (LISC) our prime funder for the New Communities Program; and a special recognition given to seniors. The GADC's newly created community video showing various leaders in the community, businesses being built, arts and culture available for Englewood and Auburn Gresham, new housing development, etc. was shown on the big screen as everyone in the audience enjoyed the revitalization progress made over the recent years.

## **On The Move** Auburn Gresham 79th Street Special Service Area (SSA)



As of January 1, 2006, the Auburn Gresham 79th Street SSA has been officially approved by the City of Chicago. The primary mission of the SSA is to promote investment and business development along the 79th Street corridor between the Dan Ryan Expressway on the East and Marshfield on the West. To accomplish this mission, the SSA will focus on economic development initiatives, maintenance, beautification and snow removal, business marketing programs and business safety issues. The SSA pilot program began the summer of 2005 utilizing CleanSlate; improving 79th Street with a much cleaner Business District. Many residents have already benefited from the maintenance, beautification and snow removal programs. This winter, because of the snow removal, residents can walk on clean sidewalks, instead of the streets. The 79th Street SSA is helping to make our Business District a safe and clean shopping area. # **Community Spotlight**

CleanSlate

At 6:30 a.m. on each weekday, the blocks encompassing the 79th Street business corridor are just waking up. But at 79th and Racine, daily Motivations are getting started and CleanSlate interns are gearing up for a busy day cleaning our neighborhood.

In June of 2005, The Cara Program - a non-profit organization serving Chicago's homeless and impoverished - launched CleanSlate, a neighborhood-beautification business providing on-the-job training and internship opportunities for students in the program who face significant obstacles to employment (including recent incarceration). CleanSlate interns kick off their day in Motivations, where students are encouraged to share insight on personal or professional lessons learned and to inspire excitement for the possibilities each new day brings. Every day, CleanSlate interns work as a team to help keep sidewalks, parkways, public gardens and vacant lots clean, and to instill renewed pride in communities. With the full support of Mayor Daley, CleanSlate also educates community residents on the importance of recycling and facilitates local recycling efforts.

In the first five months of operation, CleanSlate interns have collected 5,819 bags of recycling and garbage to keep the Auburn-Gresham community clean, and have helped renew community pride. In fact, in a survey conducted at the end of the pilot period, 83.9% of local business owners surveyed indicated that CleanSlate has had a favorable impact on their business and community vibrancy overall; and finally, because of their experience gained through CleanSlate, eight of the first ten interns (and 11 interns in total overall) have already been placed in permanent jobs with benefits in the private sector.

CleanSlate's message is one of transforming lives and transforming neighborhoods, and we are happy to have them as part of our growing Auburn-Gresham community.

How many times does Christmas come during the year? In addition to the December holiday, tax-time is another eagerly anticipated season.

In recent years, an explosion of bad loans from On the twenty-ninth of January 2006, the Greater Auburn predatory lenders and mortgage brokers has taken place across Chicago, leaving many homes subject to forecloods, such as unreasonably high interest rates, high fees and closing costs, and other underhanded scams to trick people into bad loans. Many of these lenders are only watching out for their own interest, and have no intent of making sure that people can afford to stay in their homes. These predatory practices are the new big contributor to vacant houses in many Chicago neighborhoods.
